# St Paul's Building Committee Update:

Thanks to all who attended the Annual Congregational meeting in January and participated in the vote to authorize us to engage an architect firm and to begin the process of getting bids to replace roofs.

By the time you read this, the full Building` Committee will have convened Monday, Jan 28 for a kick-off meeting.

As we discussed in the Annual Congregational meeting, we are looking at upgrades that cover things like roofs, bathrooms and HVAC, but also looking at environmentally sustainable changes such as solar panels and geothermal heat. And we are forming a team dedicated to improve the appearance and 'welcoming' look of our building. The Building Committee will meet monthly and work with an architect and vendors. Our plan is to present options and recommendations in a Congregational meeting soon after the Easter holiday. In the meantime, the Building Committee will post all minutes, etc. so everyone can stay informed and engaged. After the Congregational Meeting, we had several people approach us with ideas and suggestions (all of which are considered); as well as offers to help. We hope to keep everyone in the congregation engaged as we move forward.
